More systems implementations are using functionality out of the box vs. starting with a blank piece of paper, designing from scratch, and then trying to fit and customize software to those needs

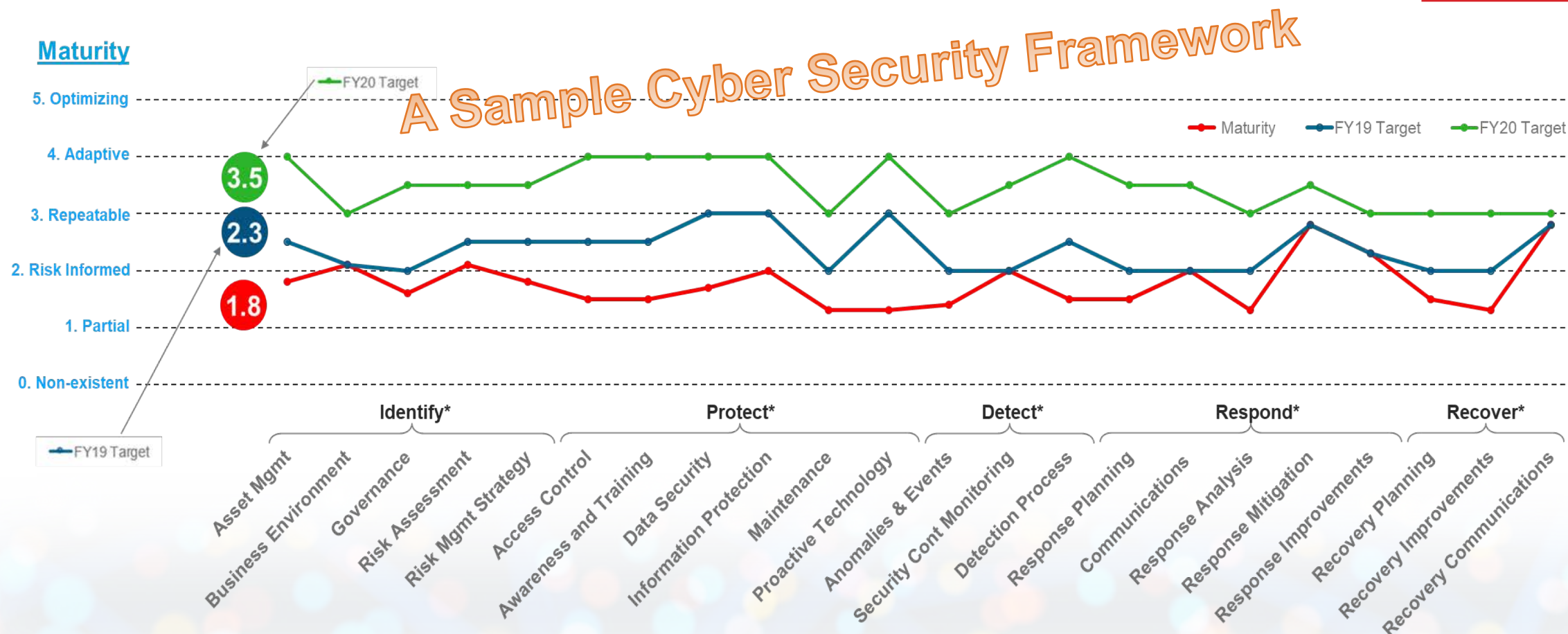
